The assistance is intended for conducting Academic Seminars, Orientation Programmes, Camps, Workshops, and Training Programmes for students.

Eligibility & Financial Support:

- This scheme is applicable to all affiliated colleges under the University.
- Financial assistance shall be up to 50% of the total expenditure of the programme or ₹25,000, whichever is less.

Instructions for Application:

1. Applications should be submitted through the DSW Portal by the Student Welfare Coordinator of the institution.
2. Each application must include:
 - Students' Welfare Institution Identification Number (SWIIN)
 - A brief proposal of the programme.
 - Tentative budget with expenditure details.
 - Details of resource persons and target student group.
 - Expected outcomes.
 - Student-centric programmes that promote academic and personal development.

The proposals received shall be scrutinised by the University, and financial assistance will be sanctioned based on the relevance, quality, feasibility of the programme, and the availability of funds under the Students' Welfare Fund. Preference shall be given to institutions that have not availed financial assistance under this scheme in previous
